Singapore, 25 February, 2021 - Straits Interactive today announced a Crisis Communications and Data Breach Response course for Data Protection Officers (DPO) through a partnership with The Media Consultants. A key objective of the course is to help organisations comply with the new requirements of the mandatory data breach notification obligations in the Personal Data Protection Act that were announced by the government on 1 February 2021.

# **Emphasis on Hands-on and Role Play**

Sharon Tong, Chief Executive Officer, The Media Consultants, said "A data breach incident may quickly escalate into a major crisis for the organisation if not properly handled. The first instinct of many companies is to keep it quiet and hope it goes away unnoticed. The new regulations on mandatory reporting make this impossible. #### Mandatory Data Breach Notification Requirement

Said Kevin Shepherdson, Chief Executive Officer, Straits Interactive, "Since 1 February, the Personal Data Protection Act requires organisations to report certain data breaches to the authorities within three calendar days after assessing that it is a 'notifiable' data breach, as well as notifying individuals that are affected by the data breach at or around the time they notify the authorities. DPOs need a systematic way to plan for, and then handle, their notification to affected individuals, together with responding to queries from the media and other stakeholders. We are delighted to





partner The Media Consultants in bringing this course to the data protection community. When we piloted this hands-on course recently, our first batch of students said that they found it to be invaluable and eye-opening as the emphasis is on planning and acting out real-life scenarios of what could well happen in a data breach. Combining a data breach response management plan with crisis communications, which includes practising media interviews with media experts truly makes this course unique in Singapore."
